1 Name of instrument

This instrument is the *Planning and Development (Planning and Land Authority) Delegation 2014 (No 1)*.

2 Commencement

This instrument commences on the day after it is made.

3 Delegation of functions

I delegate the functions of the planning and land authority under the provisions of the *Planning and Development Act 2007* identified in column 2 of the schedule to the persons who from time to time occupy the public service positions identified in column 3 for the relevant function.

Note: The Legislation Act 2001 defines “occupy”, in relation to a position, as including: to hold the position, act in the position or exercise functions of the position.
