1. Name of Instrument

This instrument is the *Public Sector Management (Heritage) Delegation 2014 (No. 3)*.

2. Commencement

This instrument commences on the day after notification.

3. Sub-delegation of *Heritage Act 2004* functions

I sub-delegate to the person who from time to time occupies a public service position identified in column 3 of table 1 of the Schedule, the corresponding functions set out in column 2 of the table.

Note 1: The *Legislation Act 2001* defines “occupy”, in relation to a position, as including: to hold the position, act in the position or exercise functions of the position.

Note 2: Under section 121 of the *Heritage Act 2004*, the Heritage Council has delegated certain functions to the Director-General with administrative responsibility for the Heritage Act, refer to *Heritage (Heritage Council) Delegation 2014 (No 1)*, NI2014-

4. Delegation of functions under the *Heritage Act 2004*

I delegate to the person who from time to time occupies the public service position identified in column 3 of table 2 of the Schedule, the corresponding function set out in column 2 of the table.
