Under section 76(3)(b)(iv) of the *Planning and Development Act 2007* and section 46 of the *Legislation Act 2001*, I repeal the Planning and Development (Draft Plan Variation no 304) Direction 2014 signed on 8 September 2014 and notified on 18 September 2014 (NI2014-452).

Under section 76(3)(b)(iii) of the *Planning and Development Act 2007*, I direct the Planning and Land Authority to consider the following revisions to the Draft Variation to the Territory Plan 304 Commercial Zones (DV304) NI2013-458:

- Retain the current limits on gross floor area for shops in group centres and town centres by omitting the proposed changes included in the recommended draft variation.
- Make provision for the redevelopment of existing shops in the commercial CZ4 local centres zone to the effect that existing shops that already exceed the proposed gross floor area limit of 1000m² should be permitted to redevelop up to their existing gross floor area.
- 3. Undertake any required edits to numbering, formatting etc. as appropriate.
