1) Attend **every session** of the 3 day training course as outlined above.

- 2) Be deemed competent in each element as listed above which cover the following units of competence from the Transport and Logistics Training package TLI10:
 - TLIC2009A Drive Taxicab
 - TLII2019A Provide Taxicab Customer Service
 - TLIB2090A Use Communication Systems in a Taxicab
 - TLIL2060A Complete Induction to the Transport Industry
 - TLIP2037A Carry out Financial Transactions and Maintain Records
 - TLIH3004A Identify Major Roads, Service and Attractions
 - TLIF2072A Comply with Safety and Security Procedures
- 3) Complete a 2 hour practical driving assessment in a fully equipped Taxi (equivalent to those required by the industry). The assessment will be conducted the following week after the course completion by TISC Authorised Assessors.
- 4) Completion of the Taxi 'T' code assessment (conducted at same time as practical driving assessment in step 3).
- 5) A driver of a Wheelchair Accessible Taxi must also achieve the competency:
 - TLICI2040A provide wheelchair accessible taxi services to passengers with disabilities. Practical assessment for this component must occur using a wheelchair accessible taxi with a TISC Authorised Assessor.
