1 Name of instrument

This instrument is the *Road Transport Legislation (Access Canberra) Delegation 2017 (No 1)*.

2 Commencement

This instrument commences on the day after notification.

3 Delegation of functions

I delegate the functions under the provisions of the road transport legislation specified in column 1 of schedule 1 to the person occupying or performing the duties of the position specified in column 3 of schedule 1.

Note 1: Position numbers in column 3 on each page have the power to exercise the functions required in column 1.

Note 2: The Head of Access Canberra is authorised to exercise functions of the Directors-General under the Territory laws that have been declared by the Chief Minister: see s21 of the Public Sector Management Act 1994.

Note 3: The power to delegate these specific functions of the Road Transport Authority was declared under s21 in NI2016-539, Public Sector Management (Head of Access Canberra Functions) Declaration 2016.

Note 4: At the time of making this instrument, the Head of Access Canberra is Deputy Director-General, Access Canberra.
