## **1 Name of instrument**

This instrument is the *Crimes (Health Directorate) Authorisation 2018 (No.1)*.

## **2 Commencement**

This instrument commences on the day it is signed.

## **3 Authorisation**

- (1) I authorise those officers employed with the Health Directorate named in the schedule to direct a person in or on directorate premises to leave those premises.
- (2) In this authorisation, *directorate premises* means any land, building or part of a building occupied by the Health Directorate.

*Note* Failure to comply with a direction of an authorised person is an offence under section 154(2)(c) of the *Crimes Act 1900*.

## **4 Revocation**

This instrument revokes all previous authorisations made in relation to Health Directorate premises for the purposes of section 154(2)(c) of the *Crimes Act 1900*.
