1 Name of instrument

This instrument is the *Road Transport (Access Canberra Parking) Delegation 2018 (No 2)*.

2 Commencement

This instrument commences on the day after notification.

3 Delegation of functions

- d. I delegate the functions under the provision of the *Road Transport (Safety and Traffic Management) Regulation 2017* specified in column 1 of schedule 4 to the person occupying or performing the duties of the position specified in column 3 of schedule 4.
