#### 1 Name of instrument

This instrument is the *Planning and Development (Technical Amendment— Removal of public land reserve overlay) Plan Variation 2018.* 

#### 2 Commencement

#### 3 Technical amendment

I am satisfied under section 89 (1) (a) of the *Planning and Development Act 2007* (the *Act*) that the removal of public land reserve overlay plan variation is a technical amendment to the Territory Plan.

*removal of public land reserve overlay plan variation* means the technical amendment to the Territory Plan, variation 2018-19, in the schedule.

*Note:* No consultation was required in relation to the removal of public land reserve overlay plan variation under section 87 of the Act.

### **1. INTRODUCTION**

#### 1.1 Purpose

## This technical amendment makes the following changes to the Territory Plan Map:

 Remove Public Land 'Pd – a special purpose reserve' overlay from Block 519 Stromlo.

#### **1.2 Public consultation**

Under section 87 of the *Planning and Development Act 2007* (the Act) this type of technical amendment is not subject to public consultation.

#### **1.3 National Capital Authority**

The National Capital Authority does not need to be advised of this technical amendment as per section 1.2 above.

#### 1.4 Types of technical amendments under the Act

The following categories of technical amendments are provided under section 87 of the Act:

- (1) Each of the following territory plan variations is a *technical amendment* for which no consultation is needed before it is made under section 89:
  - (a) a variation (an *error variation)* that
    - (i) would not adversely affect anyone's rights if approved; and
    - (ii) has as its only object the correction of a formal error in the plan;
  - (b) a variation to change the boundary of a zone or overlay under section 90A (Rezoning – boundary changes);
  - a variation, other than one to which subsection (2)(d) applies, in relation to an estate development plan under section 96 (Effect of approval of estate development plan);
  - (d) a variation required to bring the territory plan into line with the national capital plan;
  - (e) a variation to omit something that is obsolete or redundant in the territory plan.
- (2) Each of the following territory plan variations is a *technical amendment* for which only limited public consultation is needed under section 90:
  - (a) a variation (a *code variation*) that -
    - (i) would only change a code; and

- (ii) is consistent with the policy purpose and policy framework of the code; and
- (iii) is not an error variation;
- (b) a variation to change the boundary of a zone under section 90B (Rezoning – development encroaching on adjoining territory land);
- (c) a variation in relation to a future urban area under section 90C (Technical amendments future urban areas);
- (d) a variation in relation to an estate development plan under section 96 (Effect of approval of estate development plan) if it incorporates an ongoing provision that was not included in the plan under section 94 (3) (g);
- (e) a variation to clarify the language in the territory plan if it does not change the substance of the plan;
- (f) a variation to relocate a provision within the territory plan if the substance of the provision is not changed.

Following each item in Part 2 Explanation of this technical amendment is a statement of compliance against the specific criteria for the relevant category of technical amendment.

TA2018-19 has been prepared in accordance with section 87(1)(b) of the Act.

## 2. EXPLANATORY STATEMENT


#### 2.1 Background

This part of the technical amendment document explains the changes to be made to the Territory Plan, the reasons for the change, and a statement of compliance against the relevant section of the Act.

#### 2.2 Variation to the Territory Plan Map

The Conservator of Flora and Fauna has requested changes to the public land reserve overlay for Block 519 Stromlo, which is located within the Stromlo Forest Park recreation area.


Location of subject block



Stromlo Forest Park has a public land reserve overlay provision of 'Pd – a special purpose reserve'. The management objective for a special purpose reserve is "to provide for public and community use of the area for recreation and education".


A water reservoir has been constructed on Block 519 Stromlo to service the new residential development in the Molonglo valley, however the public land reserve overlay provisions for Stromlo Forest Park have not been varied to reflect the changes in land use.

The Conservator must take into consideration the management objectives when agreeing to a lease or licence of an area of public land. Icon Water has requested a direct sale of Block 519 Stromlo which contains their asset. In order to facilitate this it is appropriate that the 'Pd' overlay be removed from this block.


