1 Name of instrument

This instrument is the *Planning and Development (Planning and Land Authority) Delegation 2021*.

2 Commencement

This instrument commences on the day after its notification day.

3 Delegation of functions

I delegate the functions of the planning and land authority under the provisions of the *Planning and Development Act 2007* identified in column 2 of the schedule to the persons who from time to time occupy the public service positions identified in the corresponding entry in column 3.

Note 1 The *Legislation Act 2001* defines “occupy”, in relation to a position, as including: to hold the position, act in the position or exercise functions of the position.

Note 2 This instrument applies only to functions of the planning and land authority. For example, this instrument does not apply to functions under Division 7.3.11 (Correction and amendment of development approvals) where the decision maker is the Minister.

4 Revocation

The *Planning and Development (Planning and Land Authority) Delegation 2020 (No 3)* (NI2020-678) is revoked.
