## 1 Name of instrument

This instrument is the *Planning and Development (Inspectors) Appointment 2022 (No 2)*.

## 2 Commencement

This instrument commences on the day after it is signed.

## 3 Appointment

- 1) I appoint each person occupying or performing the duties, from time to time, of the position titles identified in column 2 of schedule 1 in the Access Canberra business unit identified in the corresponding row of column 3 of schedule 1 as an inspector for the *Planning and Development Act 2007*.
- 2) I appoint each person occupying or performing the duties, from time to time, of the position classifications identified in column 2 of schedule 2 in the Access Canberra business unit identified in the corresponding row of column 3 of schedule 2 as an inspector for the *Planning and Development Act 2007*.

*Note* The *Planning and Development (Planning and Land Authority) Delegation 2022 (No 3)* NI2022-464 delegates the power to appoint Inspectors under the *Planning and Development Act 2007* to specific public employees in Access Canberra.

## 4 Revocation

The *Planning and Development (Inspectors) Appointment 2022 (No 1)* [NI2022-200] signed 17 December 2021 is revoked.
