1. INTRODUCTION

1.1 Purpose

This technical amendment makes the following changes to the Territory Plan:

Territory Plan Map

 Change the boundary of zones on land in the Division of Strathnairn, as identified in Part 2 of this document

Strathnairn Precinct Map and Code




Figure 13 Strathnairn residential area 9

 Amend Figures 13, 14, 30 and 32 and insert new figures 13a and 14a to include ongoing provisions, and amend references to figures in rules in accordance with the new and revised figures, as described in Part 2 of this document

1.2 Public consultation

Under section 87 (1) (b) and (c) of the *Planning and Development Act 2007* (the *Act*) this type of technical amendment is not subject to public consultation.

1.3 National Capital Authority

The National Capital Authority does not need to be advised of this technical amendment as per 1.2.

1.4 Process

This technical amendment has been prepared in accordance with section 87 and made in accordance with section 89 of the Act.

1.5 Types of technical amendments under the Act

The following categories of technical amendments are provided under section 87 of the Act:

- (1) Each of the following territory plan variations is a *technical amendment* for which no consultation is needed before it is made under section 89:
 - (a) a variation (an **error variation**) that -
 - (i) would not adversely affect anyone's rights if approved; and
 - (ii) has as its only object the correction of a formal error in the plan;
 - (b) a variation to change the boundary of a zone or overlay under section90A (Rezoning boundary changes);
 - (c) a variation, other than one to which subsection (2) (d) applies, in relation to an estate development plan under section 96 (Effect of approval of estate development plan);
 - (d) a variation required to bring the territory plan into line with the national capital plan;
 - (e) a variation to omit something that is obsolete or redundant in the territory plan.
- (2) Each of the following territory plan variations is a *technical amendment* for which only limited public consultation is needed under section 90:
 - (a) a variation (a **code variation**) that
 - (i) would only change a code; and
 - (ii) is consistent with the policy purpose and policy framework of the code: and
 - (iii) is not an error variation;
 - (b) a variation to change the boundary of a zone under section 90B (Rezoning development encroaching on adjoining territory land);
 - (c) a variation in relation to a future urban area under section 90C (Technical amendments future urban areas):
 - (d) a variation in relation to an estate development plan under section 96 (Effect of approval of estate development plan) if it incorporates an ongoing provision that was not included in the plan under section 94 (3) (q);
 - (e) a variation to clarify the language in the territory plan if it does not change the substance of the plan;
 - (f) a variation to relocate a provision within the territory plan if the substance of the provision is not changed.

TA2023-01 has been prepared in accordance with section 87 (1) (b) and (c) of the Act.





Proposed Territory Plan Map




2.2 Strathnairn Precinct Map and Code


Variation to the Strathnairn Precinct Map and Code

Technical amendment TA2020-02 removed the future urban area (FUA) overlay from section 48, 49 and 50 Strathnairn and varied the Strathnairn Precinct Map and Code in accordance with the approved Estate Development Plan (EDP). The EDP was subsequently amended for sections 48 and 49 and part section 50 to change block boundaries and planning controls. This technical amendment amends the Strathnairn Precinct Map and Code in accordance with the latest approved EDP.






Proposed new figure 13a










Figure 13a Strathnairn residential area 9a




Figure 14 Strathnairn residential area 10




Figure 14a Strathnairn residential area 10a




Figure 30 Strathnairn residential area ongoing provisions
