1 Name of instrument

This instrument is the *Road Transport (Safety and Traffic Management) Approved People for Traffic Offence Detection Devices Approval 2023 (No 1)*.

2 Commencement

This instrument commences on 1 February 2023.

3 Approved people – traffic offence detection devices

- (1) I approve the people listed in schedule 1 to operate a traffic offence detection device under section 19 (2) of the *Road Transport (Safety and Traffic Management) Regulation 2017*.
- (2) In this section *traffic offence detection device* means a device or system approved (other than a mobile device detection system) under section 13 of the *Road Transport (Safety and Traffic Management) Regulation 2017*.

4 Approved people – mobile device detection system

- (1) I approve the people listed in schedule 2 to operate a traffic offence detection device under section 19 (2) of the *Road Transport (Safety and Traffic Management) Regulation 2017*.
- (2) In this section *traffic offence detection device* means a mobile device detection system approved under section 13 of the *Road Transport (Safety and Traffic Management) Regulation 2017*.

5 Revocation

This instrument revokes the *Road Transport (Safety and Traffic Management) Approved People for Traffic Offence Detection Devices Approval 2021 (No 2)* (NI2021-482).
