## 1 Name of instrument

This instrument is the *Nature Conservation (Conservator) Delegation 2023 (No 2)*.

## 2 Commencement

This instrument commences on the day after it is signed.

## 3 Delegation

I delegate the functions of the Conservator of Flora and Fauna under the provisions of the *Nature and Conservation Act 2014* specified in column 1 of schedule 1 to any person who—

(a) from time to time occupies a position:

- (i) in a branch of the Environment, Planning and Sustainable Development Directorate (*EPSDD*) specified in the corresponding entry in column 2 of schedule 1; and
- (ii) in a section of that branch specified in the corresponding entry in column 3 of schedule 1; and
- (iii) at a classification specified in the corresponding entry in column 4 of schedule 1; and

(b) is a conservation officer.

*Note 1* The *Legislation Act 2001* defines ‘occupy’ a position to include hold the position, act in the position or exercise functions of the position.

*Note 2* Conservation officers are appointed under the Act, s 28.

#### **4 Revocation**

The *Nature Conservation (Conservator) Delegation 2023* (NI2023-130) is revoked.
