#### 1.0 INTRODUCTION

#### 1.1 Outline of the process

Minor plan amendment 2024-h (MA2024-h) to the Territory Plan is a minor plan amendment (MA) prepared under section 84 2) d) of the *Planning Act 2023* (the Planning Act).

Section 84 of the Planning Act outlines the different types of MAs, some which require limited consultation to be undertaken and some which require no consultation to be undertaken.

Under Section 85 of the Planning Act a MA can only be made where:

- any required limited consultation has taken place, and the authority is satisfied that the content of the MA meets the requirements of the Planning Act
- if the MA is not inconsistent with the planning strategy or any relevant district strategy
- any comments received during the consultation period and from the National Capital Authority have been considered.

This MA required limited consultation to be undertaken and was released for limited public consultation in accordance with the *Planning Act 2023*.

The MA is not inconsistent with the planning strategy or any relevant district strategy. Further details of the changes are contained in section 3 of this document.

The National Capital Authority has received a copy of this MA.

#### 1.2 Summary of the changes

MA2024-d makes the following changes:

- Amend the Belconnen District Policy by reducing the area of:
  - a. the landfill clearance zone (Figure 20); and
  - b. the Lower Molonglo Water Quality Control Centre clearance zone (Figure 22).

#### 2.0 CONSULTATION WITH THE PUBLIC

#### 2.1 Consultation period

Under section 84 (2) (c) of the *Planning Act 2023*, this minor amendment was subject to limited public consultation of at least 20 working days.

#### 2.2 Comments from the public

Written comments were invited on MA2024-h from the public from 10 May 2024 until 7 June 2024.

No submissions were received.

The National Capital Authority has been advised of this minor amendment.

#### 3.0 TERRITORY PLAN CHANGES

This section contains details of the changes made to the Territory Plan.

#### 3.1 Belconnen District Policy

Changes are being made to reduce the area of the landfill clearance zone (Figure 20), in accordance with West Belconnen assessment requirement 52(t).

The Environment Protection Authority (EPA) has endorsed the findings in a Site Audit Report which has found that part of the landfill clearance zone is suitable (from a contamination perspective), for residential, community and sensitive uses.

Changes are being made to reduce the area of the Lower Molonglo Water Quality Control Centre clearance zone (Figure 22), in accordance with West Belconnen assessment requirement 52(u).


Following upgrades to the centre, an audit report has recommended that part of the clearance zone can be reduced from a distance of 2.45km to 2.1km. Icon Water and the EPA both approve of the proposed adjustment to the clearance zone.

The changes are not inconsistent with section 84 (2) (d) of the Planning Act 2023.

The amendment to change the provisions in the Territory Plan does not change the substance of the plan and is consistent with the policy intent of the provision.



#### Existing Figure 20 West Belconnen – Clearance Zone Map A




#### Proposed Figure 20 West Belconnen – Clearance Zone Map A

Proposed Figure 22 West Belconnen – Clearance Zone Map C






1. Figure 20 West Belconnen Clearance Zone Map A
