1 Name of instrument

This instrument is the *Freedom of Information (City and Environment Directorate Information Officers) Appointment 2025*.

2 Commencement

This instrument commences on 1 July 2025.

3 Appointment of information officers

I appoint each person who, from time to time, occupies the executive positions within the City and Environment Directorate identified in column 1 of schedule 1 to this instrument as an information officer.
