1 Name of instrument

This instrument is the *Biosecurity (Authorised People) Appointment 2025 (No 2)*.

2 Commencement

This instrument commences on the day after its notification day.

3 Appointment

- (1) I appoint as an authorised person each person who from time to time occupies a position identified in column 2 of schedule 1.
- (2) I appoint as an authorised person each person who from time to time occupies the classification of position identified in column 2, of the section identified in column 1, of schedule 2.

Note **Occupy** a position—see Legislation Act, dict, pt 1.
