Nature Conservation Act 2014, s 22 (Conservator—delegation)

1 Name of instrument

This instrument is the *Nature Conservation (Conservator) Delegation 2026 (No 1)*.

2 Commencement

This instrument commences on the day after the day it is signed.

3 Delegation

I delegate the functions of the Conservator of Flora and Fauna under the provisions of the *Nature and Conservation Act 2014* specified in column 1 of schedule 1 to any person who—

(a) from time to time occupies a position:

- (i) in a branch of the City and Environment Directorate (CED) specified in the corresponding entry in column 2 of schedule 1; and
- (ii) in a section of that branch specified in the corresponding entry in column 3 of schedule 1; and
- (iii) at a classification specified in the corresponding entry in column 4 of schedule 1; and

(b) is a conservation officer.

Note 1 The *Legislation Act 2001* defines ‘occupy’ a position to include hold the position, act in the position or exercise functions of the position.

Note 2 Conservation officers are appointed under the Act, s 28.

4 Revocation

The *Nature Conservation (Conservator) Delegation 2023 (No 3)* (NI2023-602) is revoked.
