

SEAT OF GOVERNMENT (ADMINISTRATION)

No. 1 of 1968

An Ordinance to amend the *Seat of Government (Administration) Ordinance 1930-1965*.

1.—(1.) This Ordinance may be cited as the *Seat of Government (Administration) Ordinance 1968*.* Short title and citation.

(2.) The *Seat of Government (Administration) Ordinance 1930-1965*† is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Seat of Government (Administration) Ordinance 1930-1968*.

2. Section 10 of the Principal Ordinance is amended by omitting from sub-section (6.) the words “*Seat of Government (Administration) Ordinance 1959*” and inserting in their stead the words “*Seat of Government (Administration) Ordinance 1968*”. Administration of Ordinances.

3. The Second Schedule to the Principal Ordinance is repealed and the following Schedule inserted in its stead:— Second Schedule.
