## AN ORDINANCE

### To amend the *Remuneration Ordinance 1976*

### REMUNERATION (AMENDMENT) ORDINANCE (No. 2) 1978

1. This Ordinance may be cited as the *Remuneration (Amendment) Ordinance (No. 2) 1978*.\*

Short title

2. In this Ordinance, "Principal Ordinance" means the *Remuneration Ordinance 1976*.†

Principal Ordinance

3. Section 2 of the Principal Ordinance is amended by omitting sub-section (2) and substituting the following sub-section:

Interpretation

"(2) In this Ordinance—

(a) a reference to the chairman of a prescribed authority shall be read as including a reference to a person performing the duties of the chairman of that authority; and

(b) a reference to a member of a prescribed authority shall be read as including a reference to a person acting as a member of that authority."

4. Section 3 of the Principal Ordinance is amended by omitting from sub-section (2) "Nothing in sub-sections (3) to (8)" and substituting "Except as prescribed, nothing in sub-sections (3) to (8)".

5. The Principal Ordinance is amended by adding at the end thereof the following section:

## Regulations

“ 4. The Minister may make regulations, not inconsistent with this Ordinance, prescribing all matters which by this Ordinance are required or permitted to be prescribed or which are necessary or convenient to be prescribed for carrying out or giving effect to this Ordinance.”

## Additional amendments

6. (1) The Principal Ordinance is amended as set out in the following table:

Sub-section 3 (8) .. ..	Omit “ \$45 ”, substitute “ \$49 ”.

(2) The amendments made by sub-section (1) shall be deemed to have come into operation on 1 July 1978.
