## SEAT OF GOVERNMENT (ADMINISTRATION) (AMENDMENT) ORDINANCE 1979

Short title

1. This Ordinance may be cited as the *Seat of Government (Administration) (Amendment) Ordinance 1979*.<sup>1</sup>
