#### FEDERAL CAPITAL COMMISSION.

REGULATIONS UNDER THE POUNDS ORDINANCE 1928.

PURSUANT to the powers conferred upon it by the Pounds Ordinance 1928, the Federal Capital Commission appointed under the Seat of Government (Administration) Act 1924-1928, hereby makes the following Regulations to come into operation on the date fixed for the commencement of the Ordinance.

Trespass by same cattle more than once in one month.

11. Where any cattle of any one owner are found trespassing more than once in any period of a month, the driving charges, sustenance charges and trespass rates payable in respect of those cattle arising out of any trespassing after the first, shall be double the driving charges, sustenance charges and trespass fees, respectively prescribed by regulations 4, 5 and 6 of these Regulations.

Copy of Ordinance, &c., to be kept at pound

12. The Commission shall supply to a poundkeeper and the poundkeeper shall keep at the pound, or at the poundkeeper's premises, if in the immediate neighbourhood of the pound, a copy of the Ordinance and of these Regulations and any amendments thereof, and a copy of such portions of the Gazette published during the preceding six months as relate to the registration of brands or marks used in branding and marking cattle or to impoundings.

Statement of animals impounded.

- 13. (1) A poundkeeper, upon receiving into the pound any cattle brought there for impounding, shall require the person bringing the cattle to fill in and give to the poundkeeper a statement in accordance with Form 1, and that person shall do so accordingly.
- (2) The poundkeeper shall compare the particulars contained in the statement with the cattle impounded, and, if necessary, require the statement to be corrected.
- (3) The poundkeeper shall then give to the impounder a receipt for the cattle impounded in accordance with Form 2.

Pound book

14. The pound book to be kept by the poundkeeper shall be in accordance with Form 3, and he shall enter therein at the time the particulars required of each impounding and of each dealing with impounded cattle, and such other particulars as are required.

Register of

- 15. (1) A poundkeeper shall keep a register of brands in accordance with Form 4.
- (2) At the request of the owner of any cattle and upon payment of the prescribed fees, the poundkkeeper shall enter in the register the description, brands and marks of the cattle, the date of entry and the name and address of the owner, and shall give the owner a receipt for the fee.

Feeding and watering impounded cattle.

16. (1) A poundkeeper shall, at least once each day, sufficiently feed and water cattle in his care, and where necessary may take cattle from the pound for that purpose:

Provided that where feed or water cannot, by reason of drought or other cause, be obtained, the poundkeeper shall report the fact to the Lands Officer, and the Lands Officer may give such directions as he deems advisable in the circumstances.

(2) Where the poundkeeper has so reported to the Lands Officer, he shall not, in default of any directions from the Lands Officer, or while acting in accordance with any such directions or any directions given by any officer thereto authorized by the Commission, nor shall the Commission, the Lands Officer or any such authorized officer, incur any liability for failure to feed or water cattle.

Pound to be kept dry, clean and secure

- 17. A poundkeeper shall—
  - (a) keep the pound dry, clean and secure for the due care of
  - (b) provide a pen or crush for taking the brands or descriptions of cattle; and
  - (c) in every case of doubt as to the correct reading of a brand or mark, clip or shave the brand or mark.

Diseased cattle to be kept separate.

18. A poundkeeper shall keep apart from sound cattle all cattle which he knows to be diseased, and shall report to the Lands Officer for directions any disease known to exist in any impounded cattle.

rayment of 19. A poundkeeper shall pay to the Collector of Public Moneys of feet to Collector the Commission during the Commission's office hours on any week day, of Public 19. A poundkeeper shall pay to the Collector of Public Moneys of any fees, rates or charges collected by the poundkeeper.

Payments to impounders.

- 20. (1) The Collector of Public Moneys shall pay to an impounder, on demand, during the Commission's office hours on any week day, any fees, rates or charges collected to which the impounder is entitled.
  - (2) The Collector shall take a receipt for each amount so paid.

- 21. (1) A poundkeeper, upon receipt from the owner of any cattle of complaint of notice of intention to complain to a Court of Petty Sessions under impounding, section 32 of the Ordinance, shall note that fact and the date in the poundbook.
- (2) He shall likewise enter in the poundbook the fact of the receipt of the decision of the Court and the purport thereof.
- 22. A receipt issued by a poundkeeper shall be in accordance with Receipt by poundkeeper. Form 5.
- 23. At the close of each month a poundkeeper shall prepare and Monthly forward to the Commission an account, in accordance with Form 6, of-
  - (a) all cattle in the pound at the beginning of the month;
  - (b) all cattle impounded during the month;
  - (c) all impounded cattle which have, during the month, been released or sold or have died;
  - (d) all moneys received by him during the month;
  - (e) all moneys due to him during the month;
  - (f) all notices of intention to complain served on him, during the month, under section 32 of the Ordinance;
  - (g) all cattle destroyed, during the month, the expense incurred therein, and the proceeds of the sale of the carcasses; and
  - (h) any deficiency or debt due by the owner of any cattle for fees, damages or charges.
- 24. The Lands Officer shall authorize the payment of amounts due Lands Officer to authorize to persons, other than the Commission, and shall notify the Accountant payments. of the Commission in order that steps may be taken to recover moneys due from owners of impounded cattle.
- 25. A poundkeeper shall reply forthwith, to any inquiry addressed to Inquires by him by post by any member of the public respecting any cattle which are or have been impounded in the pound, provided that the prescribed fee for an extract or copy of an entry in the books of the pound accompanies the inquiry.
- 26. Upon ceasing to hold office, the poundkeeper shall, as directed Poundkeeper by the Lands Officer, hand over all property of the Commission in his office. possession.
- 27. The notice of impounding to be given by a poundkeeper shall, Notice of where the cattle impounded are branded or marked with a registered impounding. brand or mark, be in accordance with Form 7, and shall, where the cattle impounded are not so branded or marked, be in accordance with Form 8.

- 28. The notice to be given in pursuance of sub-section (2) of section Notice of 18 of the Ordinance by an occupier impounding cattle on his own impounding. premises shall be in accordance with Form 9.
- 29. Where an occupier detains cattle in pursuance of section 21 of Notice of the Ordinance, he shall, within twenty-four hours after the commence-cattle. ment of the detention, give notice to the owner either personally or by post, or, if the owner is unknown, by advertisement in a newspaper published in the Territory, in accordance with Form 10, and may recover such costs of notice as would be recoverable by the Commission if the cattle had been impounded in a pound.
- 30. The poundkeeper shall not deliver any cattle sold in pursuance Delivery of of section 28 of the Ordinance until they are paid for; and, if they are pursuance of not paid for within fifteen minutes after the conclusion of the sale, the Ordinance. poundkeeper may put them up for resale and sell them.
- 31. The receipt to be given by a poundkeeper on releasing cattle Receipt for from a pound on payment of fees shall be in accordance with Form 11. fees for release of cattle.
- 32. Strict compliance with the forms in the Schedule to these compliance with Regulations shall not be required, and substantial compliance shall forms. suffice for the purposes of these Regulations.
