## Court of Petty Sessions Ordinance (No. 2) 1930.

I, JOHN JOSEPH DALY, Vice-President of the Executive Council, acting for and on behalf of the Attorney-General, in pursuance of the powers conferred upon me by the Court of Petty Sessions Ordinance (No. 2) 1930, do hereby make the following Rules under the said Ordinance, to come into operation on and from the twenty-first day of November, One thousand nine hundred and thirty.

Dated this 12th day of December, One thousand nine hundred and thirty.

COURT OF PETTY SESSIONS (SOLICITORS' COSTS) RULES.

Short title.

1. These Rules may be cited as the Court of Petty Sessions (Solicitors' Costs) Rules.

- 2. Where the Court fixes the costs to be paid by one party to another court to specify in respect of any proceeding or action upon a complaint, it shall the costs specify the costs in the order and shall therein order one party to pay such costs to the other.
- 3. The scale of solicitors' costs referred to in section two hundred solicitors' and forty-six in the Ordinance shall be as specified in the Schedule to costs. these Rules.
- 4. Where in any action or proceeding upon a complaint an order Costs payable is made for the payment of a sum of money which is greater or less than awarded is the amount sued for, such sum of money shall be deemed to be the greater or less than sum subject-matter for the purpose of calculating costs in accordance with sued for. the scale of costs referred to in the last preceding Rule.
