## Regulations under the Companies Ordinance 1931.

## COMPANIES REGULATIONS.

1. These Regulations may be cited as the Companies Regulations. Short title.
2. The fees payable in respect of transactions under the Companies Acts in their application to the Territory and under the Companies (Registration of Securities) Act, 1918, as adopted by the *Companies Ordinance* 1931, shall be in accordance with the Schedule to these Regulations. Fees.
