Regulations under the Pounds Ordinance 1928-1937.

AMENDMENT OF THE POUNDS REGULATIONS.

1. Regulation 3 of Pounds Regulations is amended by omitting the definition of "Lands Officer" and inserting in its stead the following definition:—

" 'authorized officer', in relation to any act, matter or thing,
means an officer thereto authorized in writing by the
Minister."

2. Regulation 4 of the Pounds Regulations is amended by omitting the word "Commission" and inserting in its stead the word "Minister".

3. Regulation 8 of the Pounds Regulations is amended by omitting the word "Commission" and inserting in its stead the word "Minister".

4. Regulation 12 of the Pounds Regulations is amended by omitting the word "Commission" and inserting in its stead the word "Minister".

5. Regulation 16 of the Pounds Regulations is amended—

(a) by omitting from sub-regulation (1.) the words "the Lands Officer" (wherever occurring) and inserting in their stead the words "an authorized officer";

(b) by omitting from sub-regulation (2.) the words "the Lands Officer" (wherever occurring) and inserting in their stead the words "an authorized officer";

(c) by omitting from sub-regulation (2.) the word "Commission" (first occurring) and inserting in its stead the word "Minister";

(d) by omitting from sub-regulation (2.) the word "Commission" (second occurring) and inserting in its stead the word "Commonwealth"; and

(e) by omitting from sub-regulation (2.) the words "or any such authorized officer".

6. Regulation 18 of the Pounds Regulations is amended by omitting the words "Lands Officer" and inserting in their stead the words "an authorized officer".

7. Regulation 19 of the Pounds Regulations is amended by omitting the words "Collector of Public Moneys of the Commission during the Commission's" and inserting in their stead the words "Receiver of Public Moneys, Department of Works, during".

8. Regulation 20 of the Pounds Regulations is amended—

- (a) by omitting from sub-regulation (1.) the words "Collector of Public Moneys" and inserting in their stead the words "Receiver of Public Moneys";
- (b) by omitting from sub-regulation (1.) the words "the Commission's"; and
- (c) by omitting from sub-regulation (2.) the word "Collector" and inserting in its stead the word "Receiver".

9. Regulation 23 of the Pounds Regulations is amended by omitting the word "Commission" and inserting in its stead the word "Minister".

Authorized
payments.

10. Regulation 24 of the Pounds Regulations is amended—

- (a) by omitting the words "The Lands Officer" and inserting in their stead the words "An authorized officer"; and
- (b) by omitting the words "other than the Commission, and shall notify the Accountant of the Commission in order that steps may be taken" and inserting in their stead the words "under the Ordinance and may cause steps to be taken".

11. Regulation 26 of the Pounds Regulations is amended—

- (a) by omitting the words "Lands Officer" and inserting in their stead the word "Minister"; and
- (b) by omitting the word "Commission" and inserting in its stead the word "Commonwealth".

12. Regulation 29 of the Pounds Regulations is amended by omitting the word "Commission" and inserting in its stead the word "Commonwealth".

Schedule.

13. The Schedule to the Pounds Regulations is amended by omitting from Form 1 the words "or of the Commission".
