## Regulations 1956. No. 1.

## **Regulations under the Motor Traffic Ordinance 1936-1956.**\*

ALLE'N FAIRHALL, the Minister of State for the Interior, in pursuance of the powers conferred on me by the Motor Traffic Ordinance 1936-1956, hereby make the following Regulations.

## AMENDMENTS OF THE MOTOR TRAFFIC REGULATIONS.

1.-(1.) Subject to this regulation, these Regulations shall come commencement. into operation on the date on which they are notified in the *Gazette*.

(2.) Regulations 2 and 5 of these Regulations shall come into operation on the date fixed by the Minister for the purposes of sub-section (3.) of section 2 of the Motor Traffic Ordinance 1956.

2. Regulation 5 of the Motor Traffic Regulations is amended by Definitions. omitting from the definition of "public stand" the words "Motor Hire Car Regulations" and inserting in their stead the words "Taxi and Private Hire Car Regulations ".

3. Regulation 9 of the Motor Traffic Regulations is amended by Registration omitting from sub-regulation (2.) the words "in accordance with of trailers. Form B in the First Schedule to these Regulations".

- 4. Regulation 11A of the Motor Traffic Regulations is amended— Sale or transfer of (a) by omitting from sub-regulation (1.) the words "owners' trailers. certificate'
  - (b) by omitting from sub-regulation (1.) the word "each" and inserting in its stead the word "the"; and
  - (c) by omitting sub-regulation (3.) and inserting in its stead the following sub-regulation :--

"(3.) If the Registrar approves of the transfer, he shall on payment by the applicant to the Commonwealth of a fee of Two shillings and sixpence, transfer the registration of the trailer to the applicant.".
