Regulations under the *Plant Diseases Ordinance 1934**

AMENDMENTS OF THE PLANT DISEASES REGULATIONS†

1. Regulation 2 of the Plant Diseases Regulations is repealed. Parts

2. Regulation 20 of the Plant Diseases Regulations is repealed and the following regulation substituted:

“ 20. (1) A person shall not sell within the Territory, or export from the Territory, fruit packed in a case unless the case is of a description specified in column 1 of the Second Schedule and has the internal dimensions specified in column 2 of that Schedule opposite to that description. “ (2) In this regulation, ‘ case ’ does not include a bag or sack.”.
