Regulations under the Cemeteries Ordinance 19331

# AMENDMENTS OF THE CANBERRA PUBLIC CEMETERY REGULATIONS<sup>2</sup>

**1.** Regulation 1 of the Canberra Public Cemetery Regulations is repealed and the following regulation substituted:

"1. These Regulations may be cited as the Canberra Public Cemeteries Regulations.".

2. Regulation 2 of the Canberra Public Cemetery Regulations is amended—

- (a) by inserting in sub-regulation (1) before the definition of "grave" the following definition:
  - " 'Canberra Public Cemeteries' means the public cemeteries in the Territory; ";
- (b) by omitting from sub-regulation (1) the definitions of "the Cemetery" and "the Groundsman" and substituting the following definition:
  - " 'the Groundsman', in relation to a public cemetery, means a person appointed to be the Groundsman in respect of that public cemetery: "; and
- (c) by omitting from sub-regulation (1) the definition of "the Trustees" and substituting the following definition:
  - "the Trustees' means the persons appointed to be the Trustees of the Canberra Public Cemeteries;".

Interpretation 3. Regulation 4 of the Canberra Public Cemetery Regulations is Seal of amended by omitting from sub-regulation (1) "Second Schedule" and Trustees substituting "Schedule 1".

4. Regulation 6 of the Canberra Public Cemetery Regulations is Fees and amended by omitting from sub-regulation (1) "Third Schedule" and charges substituting "Schedule 2".

5. Regulation 11 of the Canberra Public Cemetery Regulations is Public amended by omitting "The Cemetery" and substituting "Each public cemetery hours cemetery".

6. Regulation 12 of the Canberra Public Cemetery Regulations is Time of amended—

- (a) by omitting "The Cemetery" and substituting "Each public cemetery"; and
- (b) by omitting "during which the Cemetery" and substituting "during which a public cemetery".

7. Regulations 13 and 14 of the Canberra Public Cemetery Regulations are repealed and the following regulations substituted:

"13. The Trustees shall erect in a conspicuous part of each public Notice board cemetery, and maintain in good order, a notice board indicating—

- (a) the name of the public cemetery;
- (b) the hours during which the public cemetery is open to the public;
- (c) the name of the Secretary; and
- (d) the address of the office of the Trustees.

"14. (1) The Trustees shall cause plans to be prepared showing a Plans of public cemetery. Plans of public cemeteries

"(2) The plans referred to in sub-regulation (1) shall be kept at the office of the Trustees.

"(3) A copy of the plan of a public cemetery shall be kept at the public cemetery.".

8. Regulation 15 of the Canberra Public Cemetery Regulations is Exclusive amended by omitting from sub-regulation (1) "the Cemetery" and sub-rights to burial stituting "a public cemetery".

9. Regulation 16 of the Canberra Public Cemetery Regulations is Register of amended by omitting "the Cemetery" and substituting "each public allotments, burials, &c. cemetery".

10. Regulation 18 of the Canberra Public Cemetery Regulations is Permit for amended by omitting from sub-regulation (1) "the Cemetery" and sub-<sup>burial</sup> stituting "a public cemetery".

11. Regulation 19 of the Canberra Public Cemetery Regulations is amended by omitting from paragraph (a) "Registration of Births, Marriages and Deaths Ordinance 1929-1938" and substituting "Registration of Births, Deaths and Marriages Ordinance 1963".

12. Regulation 24A of the Canberra Public Cemetery Regulations is repealed and the following regulation substituted:

"24A. Notwithstanding anything contained in regulation 24, not more than one body shall be buried in an allotment specially set apart in pursuance of paragraph 5 (1) (c) of the Cemeteries Ordinance 1933.".

13. Regulation 26 of the Canberra Public Cemetery Regulations is amended by omitting from sub-regulation (1) "the Cemetery" and substituting "a public cemetery".

14. Regulation 27 of the Canberra Public Cemetery Regulations is amended by omitting "the Cemetery" and substituting "a public cemetery".

15. Regulation 27A of the Canberra Public Cemetery Regulations is amended by omitting from sub-regulation (1) "the Cemetery" and substituting "a public cemetery".

16. Regulation 28 of the Canberra Public Cemetery Regulations is amended by omitting "the Cemetery" (wherever occurring) and substituting "a public cemetery".

17. Regulation 29 of the Canberra Public Cemetery Regulations is amended by omitting from sub-regulation (1) "the Cemetery" and substituting "a public cemetery".

18. Regulation 30 of the Canberra Public Cemetery Regulations is amended by omitting from paragraph (a) "the cemetery" and substituting "a public cemetery".

19. Regulation 32 of the Canberra Public Cemetery Regulations is amended by omitting from paragraph (c) "the cemetery" and substituting "a public cemetery".

**20.** Regulation 33 of the Canberra Public Cemetery Regulations is amended-

(a) by omitting "within the cemetery" and substituting "within a public cemetery"; and



- (b) by omitting from item 7 "the Cemetery" and substituting "a public cemetery"; and
- (c) by omitting from item 8 "Exhumation and reburial in another allotment in the Cemetery" and substituting "Exhumation from a public cemetery and reburial in another allotment in that public cemetery".
