AMENDMENTS OF THE TAXI AND PRIVATE HIRE CAR REGULATIONS²

Taxi fares

1. Regulation 24 of the Taxi and Private Hire Car Regulations is amended—

- (a) by omitting from paragraph (3) (a) “32 cents” and substituting “37 cents”;
- (b) by omitting from paragraph (3) (b) “27 cents” and substituting “32 cents”;
- (c) by omitting from paragraph (3A) (a) “24 cents” and substituting “28 cents”;
- (d) by omitting from paragraph (3A) (b) “20 cents” and substituting “24 cents”;
- (e) by omitting from paragraph (4A) (a) “32” and substituting “37”; and
- (f) by omitting from paragraph (4A) (b) “40” and substituting “42”.

2. Schedule 2 to the Taxi and Private Hire Car Regulations is Schedule 2 repealed and the following Schedule substituted:
