Regulations under the Dentists Registration Ordinance 1931

AMENDMENTS OF THE DENTAL REGULATIONS²

- 1. After regulation 1 of the Dental Regulations, the following regulation is inserted:
- "1A. In these Regulations, 'the Ordinance' means the *Dentists Registration Ordinance* 1931.".
- 2. Regulations 4 and 5 of the Dental Regulations are repealed and the following regulations substituted:
- Particulars to be entered in Registers

Interpretation

- "4. The following are the prescribed particulars relating to a person for the purposes of sub-sections 20(1), 23C(1) and 23H(1) of the Ordinance:
 - (a) the number allocated to the entry of the person's name;
 - (b) the date of registration;
 - (c) in the case of a person registered as a dentist—the professional address of the person;
 - (d) in the case of a person registered as a dental assistant or dental hygienist—the address of the person by whom the first-mentioned person is employed;
 - (e) the qualifications by reason of which the person was entitled to be registered or to apply for registration.

Fee for registration

"5. The prescribed fee for the purposes of sub-sections 22 (3), 23A (3), 23E (1), 23F (1), 23K (1) and 23L (1) is \$2.10.".

3. Regulation 6 of the Dental Regulations is amended by adding at Certificate the end thereof the following sub-regulations:

"(2) A certificate issued for the purpose of sub-section 23E (2) of the Ordinance shall be in accordance with the following form:
