AMENDMENTS OF THE MOTOR VEHICLE (THIRD PARTY INSURANCE) REGULATIONS²

Commencement 1. These Regulations shall come into operation on 23 April 1979.

Premium rates

2. Regulation 16 of the Motor Vehicle (Third Party Insurance) Regulations is amended by omitting from sub-regulation (2) "\$100.00" and substituting "\$131.00".

First Schedule 3. The First Schedule to the Motor Vehicle (Third Party Insurance) Regulations is amended by omitting Part II and substituting the following Part:
