Nature Conservation Regulations

I, WILLIAM MICHAEL HODGMAN, the Minister of State for the Capital Territory, hereby make the following Regulations under the *Nature Conservation Ordinance* 1980.

Citation

1. These Regulations may be cited as the Nature Conservation Regulations.

Interpretation

2. In these Regulations, "the Ordinance" means the *Nature Conservation Ordinance* 1980.

Records to be kept in respect of animals

3. (1) For the purposes of section 71 and sub-section 72 (1) of the Ordinance, the records to be kept by a person who is the holder of a permit or licence in respect of the animals, other than animals of a kind referred to in Schedule 5 or 6 to the Ordinance, kept by him are—

- (a) a record of the number, species and sex of the animals;
- (b) in respect of an animal acquired from another person—
 - (i) a record of the species and sex of the animal;
 - (ii) a record of the date of receipt of the animal; and
 - (iii) a record of the name and address of that other person;
- (c) in respect of an animal that dies or escapes from captivity—
 - (i) a record of the species and sex of the animal; and
 - (ii) a record of the date on which the animal died or escaped; and
- (d) in respect of an animal that is transferred, whether in pursuance of a sale or otherwise, to another person—
 - (i) a record of the species and sex of the animal;
 - (ii) a record of the date of transfer; and
 - (iii) a record of the name and address of the person receiving the animal.

(2) Notwithstanding sub-section (1), a person is required to keep a record of the sex of an animal only where it is possible to ascertain, without handling the animal, the sex of that animal.

Records to be kept in respect of live fish

4. For the purposes of sub-section 72 (2) of the Ordinance, the records to be kept by a person who is the holder of a licence in respect of live fish kept by him are --

- (a) a record of the species of the fish;
- (b) in respect of live fish acquired from another person—
 - (i) a record of the species of the fish;
 - (ii) a record of the date of receipt of the fish; and
 - (iii) a record of the name and address of that other person;
- (c) in respect of live fish that are transferred, whether in pursuance of a sale or otherwise, to a person who is the holder of a licence authorizing him to sell live fish—
 - (i) a record of the species of the fish;
 - (ii) a record of the date of transfer; and
 - (iii) a record of the name and address of the person receiving the fish; and
- (d) in respect of live fish that are exported from the Territory by the person—
 - (i) a record of the species of the fish;
 - (ii) a record of the date of export; and
 - (iii) a record of the name and address of the person receiving the fish.

Records to be kept in respect of plants that are wildlife

5. For the purposes of sub-section 72 (3) of the Ordinance, the records to be kept by a person who is the holder of a licence authorizing him to sell or export from the Territory plants that are wildlife are—

- (a) a record of the number and species of plants sold or exported from the Territory;
- (b) a record of the date on which the plants were sold or exported from the Territory; and
- (c) a record of the name and address of the person receiving the plants.

Licence to take animals—fee

6. The prescribed fee for the grant of a licence to take an animal that is wildlife is \$50.

Licence to sell animals—fee

7. The prescribed fee for the grant of a licence to sell animals, whether wildlife or not, is --

- (a) where the number of animals to which the licence applies does not exceed 10—\$5;

- (b) where the number of animals to which the licence applies exceeds 10 but does not exceed 100—\$10; and
- (c) where the number of animals to which the licence applies exceeds 100—\$50.

Licence to import or export—fees

8. The prescribed fee for the grant of a licence to import into, or export from, the Territory

- (a) an animal, whether wildlife or not; or
- (b) live fish,

is \$10.

Licence to sell fish—fee

9. The prescribed fee for the grant of a licence to sell live fish is \$50.

Licences to pick plants that are wildlife—fees

10. The prescribed fee for the grant of a licence to pick a plant that is wildlife or to pick restricted plant wildlife is

- (a) where the number of plants to which the licence applies does not exceed 10—\$10; and
- (b) where the number of plants to which the licence applies exceeds 10—\$50.

Licence to fell or remove timber—fee

11. The prescribed fee for the grant of a licence to fell or remove timber is \$10.
