**Boilers and Pressure Vessels Regulations²
(Amendment)**

Issue of boiler attendant's certificate

1. Regulation 39 of the Boilers and Pressure Vessels Regulations is amended by omitting from sub-regulation (1) "\$1" and substituting "\$15".
