## About this republication

### The republished law

This is a republication of the *Epidemiological Studies (Confidentiality) Regulation 1992* effective from 27 April 2000 to 11 September 2001.

### Kinds of republications

### Editorial changes

The *Legislation (Republication) Act 1996*, part 3, division 2 authorised the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation (Republication) Act 1996*, s 14 and s 16). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

## Epidemiological Studies (Confidentiality) Regulations 1992

**Epidemiological Studies (Confidentiality) Act 1992**

### **1 Name of regulations**

These regulations are the *Epidemiological Studies (Confidentiality) Regulations 1992*.

### **2 Commencement**

These regulations commence on the day on which they are notified in the Gazette.

### **3 Definitions**

In these regulations:

***the Act*** means the *Epidemiological Studies (Confidentiality) Act 1992*.

*Note* A definition applies except so far as the contrary intention appears (see *Interpretation Act 1967*, s 11G as applied by the *Subordinate Laws Act 1989*, s 9).

**4 Prescribed study—controlled availability of opioids**

(1) For the purposes of paragraph (b) of the definition of *prescribed study* in subsection 3 (1) of the Act, the Territory epidemiological study known as the *Feasibility Research into the Controlled Availability of Opioids*, being the study—

- (a) in relation to the feasibility of a trial of providing opioids in a controlled manner to users of opioids in the Territory; and
- (b) that is conducted jointly by the National Centre for Epidemiology and Population Health and the Australian Institute of Criminology; and
- (c) that commenced in May 1991;

is declared to be a study to which the Act applies.

(2) In subregulation (1)—

*opioid* means—

- (a) opium; or
- (b) a drug that has a morphine-like pharmacological effect, being a synthetic or semisynthetic drug or an opium derivative.

**5 Prescribed study—parenting practices of drug users**

For paragraph (b) of the definition of *prescribed study* in subsection 3 (1) of the Act, the Territory epidemiological study known as *Parenting in the Socio-cultural Context of Illicit Drug or Harmful Alcohol Use* that—

- (a) relates to the parenting ideas and practices of different groups of women, including illicit drug users; and
- (b) is conducted by the National Centre for Epidemiology and Population Health; and
- (c) began in September 1998;

is declared to be a study to which the Act applies.

**6 Prescribed study—combating child abuse by drug users**

For paragraph (b) of the definition of *prescribed study* in subsection 3 (1) of the Act, the Territory epidemiological study known as *An Evaluation of an Intervention Program to Combat Child Abuse and Neglect and to Provide Health Promotion for Children of Drug Users* that—

- (a) relates to—
  - (i) the factors responsible for the incidence and distribution of child abuse among drug users; and
  - (ii) the effectiveness of a program to combat child abuse and neglect by drug users and to provide health promotion for the children of drug users; and
- (b) is conducted by the National Centre for Epidemiology and Population Health; and
- (c) began in December 1998;

is declared to be a study to which the Act applies.

**7 Prescribed study—supervised injecting place trial**

For paragraph (b) of the definition of *prescribed study* in subsection 3 (1) of the Act, the scientific trial for the *Supervised Injecting Place Trial Act 1999* and a study that is part of or ancillary to the trial are declared to be studies to which the Act applies.

### ENDNOTES

#### 1 About this republication

This is a republication of the *Epidemiological Studies (Confidentiality) Regulations 1992* as in force under the *Epidemiological Studies (Confidentiality) Act 1992* on 1 June 2000. It includes all amendments made to the regulations up to Subordinate Law 2000 No 19.

Amending laws are annotated in the table of legislation and table of amendments.

The Parliamentary Counsel's Office currently prepares 2 kinds of republications of ACT laws: authorised printed republications to which the *Legislation (Republication) Act 1996* applies and unauthorised electronic republications. The status of this republication appears on the cover.

Section 13 of the *Legislation (Republication) Act 1996* authorises the Parliamentary Counsel, in preparing a law for republication, to make textual amendments of a formal nature which the Parliamentary Counsel considers desirable in accordance with current legislative drafting practice. The amendments do not effect a substantive change in the law.

In preparing this republication, amendments have not been made under section 13.

Not all amendments made under section 13 are annotated in the table of amendments. Full details of any amendments can be obtained from the Parliamentary Counsel's Office.

#### 2 About the republished subordinate law

The *Epidemiological Studies (Confidentiality) Regulations 1992* were originally the *Epidemiological Studies (Confidentiality) Regulations*. They were renamed by the *Epidemiological Studies (Confidentiality) Regulations Amendment 1999* No 28 (see reg 3).
