1. Commencement

These Regulations commence on 1 July 1998.

2. Principal Regulations

In these Regulations, "Principal Regulations" means the *Motor Vehicle (Third Party Insurance) Regulations*.

3. Premium rates

Regulation 16 of the Principal Regulations is amended by omitting from subregulation (2) "\$107" and substituting "\$133.50".

4. Schedule 1

Schedule 1 to the Principal Regulations is amended by omitting Part II and substituting the following Part:
