About this republication

The republished law

This is a republication of the Magistrates Court (Smoking in Cars with Children Infringement Notices) Regulation 2012, made under the Magistrates Court Act 1930 (including any amendment made under the Legislation Act 2001, part 11.3 (Editorial changes)) as in force on 1 May 2012. It also includes any commencement, repeal or expiry affecting this republished law.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the *Legislation Act 2001* applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

Editorial amendments

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication does not include amendments made under part 11.3 (see endnote 1).

Uncommenced provisions and amendments

If a provision of the republished law has not commenced, the symbol $[\underline{U}]$ appears immediately before the provision heading. Any uncommenced amendments that affect this republished law are accessible on the ACT legislation register (www.legislation.act.gov.au). Modifications

1 Name of regulation

This regulation is the Magistrates Court (Smoking in Cars with Children Infringement Notices) Regulation 2012.

3 Dictionary

- *Note* 2 A definition in the dictionary applies to the entire regulation unless the definition, or another provision of the regulation, provides otherwise or the contrary intention otherwise appears (see Legislation Act, s 155 and s 156 (1)).

4 Notes

A note included in this regulation is explanatory and is not part of this regulation.

Purpose of regulation

The purpose of this regulation is to provide for infringement notices under the *Magistrates Court Act 1930*, part 3.8 for certain offences against the *Smoking in Cars with Children (Prohibition) Act 2011*.

Note The *Magistrates Court Act 1930*, pt 3.8 provides a system of infringement notices for offences against various Acts. The infringement notice system is intended to provide an alternative to prosecution.

Administering authority

The administering authority for an infringement notice offence against the *Smoking in Cars with Children (Prohibition) Act 2011* is the director-general for that Act.

7 Infringement notice offences

The *Magistrates Court Act 1930*, part 3.8 applies to an offence against a provision of the *Smoking in Cars with Children* (*Prohibition*) *Act 2011* mentioned in schedule 1, column 2.

8 Infringement notice penalties

- (1) The penalty payable by an individual for an offence against the *Smoking in Cars with Children (Prohibition) Act 2011*, under an infringement notice for the offence, is the amount mentioned in schedule 1, column 4 for the offence.
- (2) The cost of serving a reminder notice for an infringement notice offence against the *Smoking in Cars with Children (Prohibition)* Act 2011 is \$34.

9 Contents of infringement notices—identifying authorised person

An infringement notice served on a person by an authorised person for an infringement notice offence against the *Smoking in Cars with Children (Prohibition) Act 2011* must identify the authorised person by the police officer's service number.

10 Contents of reminder notices—identifying authorised person

A reminder notice served on a person by an authorised person for an infringement notice offence against the *Smoking in Cars with Children (Prohibition) Act 2011* must identify the authorised person by the police officer's service number.

11 Authorised people for infringement notice offences

A police officer may serve—

- (a) an infringement notice for an infringement notice offence against the *Smoking in Cars with Children (Prohibition) Act 2011*; and
- (b) a reminder notice for an infringement notice offence against the *Smoking in Cars with Children (Prohibition) Act 2011.*
