**1 Name of regulation**

This regulation is the *Crimes (Child Sex Offenders) Amendment Regulation 2012 (No 1)*.

**2 Commencement**

This regulation commences on the day after its notification day.

*Note* The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

**3 Legislation amended**

This regulation amends the *Crimes (Child Sex Offenders) Regulation 2005*.

*insert*

- (o) the commissioner for fair trading exercising functions under the *Working with Vulnerable People (Background Checking) Act 2011*.

**8 New section 18 (da) and (db)**

*insert*

- (da) a child sex offender registration order under the *Child Sex Offenders Registration Act 2006* (SA);
- (db) an offender reporting order under the *Community Protection (Offender Reporting) Act 2005* (TAS);

**9 New section 19 (da) and (db)**

*insert*

(da) *Child Sex Offenders Registration Act 2006 (SA)*;

(db) *Community Protection (Offender Reporting) Act 2005 (TAS)*;
