1 Name of regulation

This regulation is the *Lifetime Care and Support (Catastrophic Injuries) Regulation 2015.*

2 Commencement

This regulation commences on the day after its notification day.

Note The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

3 Dictionary

The dictionary at the end of this regulation is part of this regulation.

5 Authorised people—Act, s 12

The following people are prescribed:

- (a) the Lifetime Care and Support Authority of New South Wales;
- (b) the general manager (however described) of the Lifetime Care and Support Authority of New South Wales;

(c) an authorised person under the *Motor Accidents (Lifetime Care and Support) Act 2006* (NSW), section 41 (3) (Delegation of functions).
