About this republication

The republished law

This is a republication of the City Renewal Authority and Suburban Land Agency (Transitional Provisions) Regulation 2017 (repealed), made under the City Renewal Authority and Suburban Land Agency Act 2017, including any amendment made under the Legislation Act 2001, part 11.3 (Editorial changes). It also includes any commencement, amendment, repeal or expiry affecting this republished law to 2 July 2018.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

Kinds of republications

Editorial changes

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication does not include amendments made under part 11.3 (see endnote 1).

Uncommenced provisions and amendments

If a provision of the republished law has not commenced, the symbol **U** appears immediately before the provision heading. Any uncommenced amendments that affect this republished law are accessible on the ACT legislation register (www.legislation.act.gov.au). For more information, see the home page for this law on the register.

Modifications

Penalties

At the republication date, the value of a penalty unit for an offence against this law is \$150 for an individual and \$750 for a corporation (see *Legislation Act 2001*, s 133).

1 Name of regulation

This regulation is the City Renewal Authority and Suburban Land Agency (Transitional Provisions) Regulation 2017.

3 Transitional—modification of Act, pt 10—Act, s 200 (2)

The Act, part 10 applies as if the following section were inserted:

'200A Modification—Planning and Development Act 2007

- (1) The *Planning and Development Act 2007* is modified as set out in the *City Renewal Authority and Suburban Land Agency (Transitional Provisions) Regulation 2017*, schedule 1.
- (2) This section expires on the day the City Renewal Authority and Suburban Land Agency (Transitional Provisions) Regulation 2017 expires.'

4 Expiry

This regulation expires on the day the *City Renewal Authority and Suburban Land Agency Act 2017*, part 10 expires.
