Table 2 lists, in alphabetical order, Acts notified in 2013. For amending Acts, it also lists each Act or SL amended by the Act.

Table 3 Numerical table of subordinate laws 2013

Table 3 lists, in numerical order, subordinate laws notified in 2013 including their notification and commencement details.

Table 4 Alphabetical table of subordinate laws 2013

Table 4 lists, in alphabetical order, subordinate laws (SLs) notified in 2013. For amending SLs, it also lists each Act or SL amended by the SL.

Table 5 Alphabetical table of new and affected legislation 2013

Table 5 contains details of Acts and subordinate laws notified, amended, modified or commencing in 2013. Table 5 also contains bills currently before the Legislative Assembly.

How Acts and bills appear in table 5

Acts and bills are listed-

- in alphabetical order, and
- under the Act they amend if they are amending Acts or bills.

Example

Wombat Act 1992 A1992-23

How subordinate laws appear in table 5

Subordinate laws appear under the Act under which they are made.

Example

Platypus Act 2000 A2000-68

Bills information in table 5

A reference to a bill passed by the Legislative Assembly also includes the date it is passed.

Example

Kookaburra Act 2001 A2001-82

 proposed am by Native Birds Amendment Bill 2013 passed 21 February 2013

The letters (PMB) after the title of a bill indicate that the bill was presented by a Private Member, that is, the bill is not a government bill.

Notification and commencement in table 5

Notification and commencement details

Details of notification and commencement are included. These details are listed under the Act or subordinate law, wherever the Act or subordinate law appears in the table.

Example

Kangaroo Act 1992 A1992-24

 am by Kangaroo Amendment Act 2013 A2013-3 notified LR 14 March 2013 commenced 15 March 2013 (s 2)

The provisions of a law providing for its name and commencement automatically commence on the day after notification of the law unless the law otherwise expressly provides (see Legislation Act, s 75 (1)).

Uncommenced legislation

If provisions of an Act or subordinate law are not yet in force, the commencement details are underlined.

Example

Brush-tailed Rock Wallaby Amendment Act 2002 A2002-63

Default commencement of postponed law

If a postponed law has not commenced within 6 months beginning on its notification day, it automatically commences on the first day after that period (see Legislation Act, s 79). A note indicates the date of the default commencement.

Example

Echidna Act 2013 A2013-5

s 1, s 2 commenced 24 January 2013 (LA s 75 (1))
remainder awaiting commencement (s 2)
Note default commencement under LA s 79: 24 July 2013

A postponed law does not automatically commence on the first day after that period if the law expressly states that the Legislation Act, s 79 does not apply. A note indicates when a default commencement does not apply.

Example

Emu Act 1933 A1933-53

 am by Emu Legislation Amendment Act 2013 A2013-63 pt 11 <u>pt 11 awaiting commencement (s 2 (1))</u>

 Note default commencement under LA s 79 does not appl

default commencement under LA s 79 does not apply to this Act

References in table 5

Cross-references for changed names

If the changed name of legislation is significantly different from its previous name, a cross-reference will also be included in its previous alphabetical place.

Example

Pink-tailed Legless Lizard Act 1971—see Pink-tailed Legless Lizard Protection Act 1971

If the name of subordinate legislation is significantly different from the name of the empowering Act, a cross-reference will appear in the alphabetical place for the subordinate legislation's name.

Example

Monotreme Regulation—see Platypus Act 2000

References to expired provisions

If a law providing for the expiry of all or some of its provisions is made, details of the expiry are included in the table. Uncommenced expiry details are underlined.

Example

Corroboree Frog Act 1912 A1912-34

Note pt 6 exp 29 November 2013 (s 29 (1))

References to repealed legislation

If a law has been included in table 5 because it was made or amended in 2013 and it is subsequently repealed in 2013, the law remains in table 5. However, the word 'repealed' appears after the name. If the repeal has not commenced, the word 'repealed' is underlined. The law also appears in table 6 – Alphabetical table of repealed legislation.

Example

Bilby (Expiry) Regulation 2013 SL2013-18 (repealed—see table 6)

Table 6 Alphabetical table of repealed legislation 2013

Table 6 contains Acts and subordinate laws repealed in 2013. Legislation that has lapsed, expired or ceased to have effect is treated as repealed legislation. Table 6 includes proposed repeals by bills.

How legislation appears in table 6

Table 6 shows Acts and subordinate laws repealed in 2013 in alphabetical order. Notification and commencement details for the repealing provisions are included. Some repealing laws were notified before 2013, but the repealing provision only commenced in 2013. Other repealing laws were notified in 2013 and the repealing provision commenced in 2013. In some cases notification happened in 2013, but the repealing provision had not yet commenced.

If the repealing legislation has commenced, the repealed legislation appears in bold type.

Example

Possum Act 1994 A1994-32

 s 31 commenced 28 May 2013 (s 2 (1))

If the repealing legislation has not yet commenced, the entry appears in light type and is underlined.

Example

Flying Fox Act 1902 A1902-69

Repealed subordinate laws are listed under the Act under which they are made. However, if the authorising Act has not been repealed its title appears in light type.

Example

Smoky Mouse Act 1901 A1901-62

Smoky Mouse Regulation 1902 SL1902-8

rep by Smoky Mouse Repeal Regulation 2013 SL2013-10 10 notified LR 7 March 2013 commenced 8 March 2013 (s 2)

Automatic repeal of amending or repealing laws

An amending or repealing law is automatically repealed on the day after all of its provisions have commenced (see *Legislation Act 2001*, s 89 (1) and (10), def *amending law*). However, the repeal of an amending or repealing law does not affect the continuing operation of the amendments or revive the repealed law (see *Legislation Act 2001*, s 86).

Example
