1 **1 Name of Act**

2 This Act is the *Justice and Community Safety Legislation*
3 *Amendment Act 2009*.

4 **2 Commencement**

- 5 (1) Section 3 and schedule 1, part 1.2, part 1.7 and part 1.9 commence
6 on the day after this Act's notification day.

7 *Note* The naming and commencement provisions automatically commence on
8 the notification day (see Legislation Act, s 75 (1)).

- 9 (2) Schedule 1, part 1.1 and part 1.5 commences immediately after the
10 later of—

11 (a) the commencement of the *Domestic Violence and Protection*
12 *Orders Act 2008*; and

13 (b) the commencement of this Act, section 3.

- 14 (3) Schedule 1, part 1.3 and part 1.4 commences immediately after the
15 later of—

16 (a) the commencement of the *Children and Young People*
17 *Act 2008*, schedule 1, part 1.4; and

18 (b) the commencement of this Act, section 3.

- 19 (4) Schedule 1, part 1.6 and part 1.8 commences immediately after the
20 commencement of the *Crimes Legislation Amendment Act 2008*,
21 schedule 1, part 1.1.

22 **3 Legislation amended**

23 This Act amends the legislation mentioned in schedule 1.

3 **Part 1.1** **Bail Act 1992**

4 **[1.1]** **Section 9F (6), definition of *relevant person*, note**

5 *substitute*

6 *Note* The *Domestic Violence and Protection Orders Act 2008*, s 15 (1)
7 defines a ***relevant person*** in relation to a person (the ***original person***) as
8 any of the following people:

- 9 • a domestic partner or former domestic partner of the original
10 person (***domestic partner*** is defined in the Legislation Act,
11 s 169 (1))
- 12 • a relative of the original person (***relative*** is defined in the *Domestic*
13 *Violence and Protection Orders Act 2008*, s 15A)
- 14 • a child of a domestic partner or former domestic partner of the
15 original person
- 16 • a parent of a child of the original person
- 17 • someone who is or has been in a relevant relationship with the
18 original person (***relevant relationship*** is defined in the *Domestic*
19 *Violence and Protection Orders Act 2008*, s 15).

1 **Part 1.2** **Crimes (Forensic Procedures)**
2 **Act 2000**

3 **[1.2] Section 40, except note**

4 *substitute*

5 **40 Suspect in custody may be kept in custody for carrying**
6 **out forensic procedure**

- 7 (1) This section applies if a magistrate orders the carrying out of a
8 forensic procedure on a suspect mentioned in section 32
9 (Circumstances in which magistrate may order forensic procedure).
- 10 (2) If the suspect is in custody, the suspect may be detained in custody
11 for as long as reasonably necessary to carry out the forensic
12 procedure.
- 13 (3) An order made in the circumstances set out in section 32 (c)
14 operates despite any other law.

17 **40A Magistrate may order arrest etc of suspect not in custody**
18 **for carrying out forensic procedure**

- 19 (1) This section applies if a magistrate orders the carrying out of a
20 forensic procedure on a suspect mentioned in section 32 (a *forensic*
21 *procedure order*).
- 22 (2) If the suspect is not in custody, the magistrate may, on the
23 application of an authorised applicant, also make an order (an *arrest*
24 *and removal order*) for—
- 25 (a) the arrest of the suspect for the purpose of carrying out the
26 forensic procedure; and

- 1 (b) the removal of the suspect to the place where the forensic
2 procedure is to be carried out.
- 3 (3) The magistrate may make an arrest and removal order only if
4 satisfied that—
- 5 (a) the order is necessary to ensure that the forensic procedure will
6 be carried out; or
- 7 (b) the suspect might destroy evidence that might be obtained by
8 carrying out the forensic procedure; or
- 9 (c) the order is otherwise justified.
- 10 (4) An authorised applicant may apply for an arrest and removal order
11 in relation to a suspect—
- 12 (a) when the authorised applicant applies for a forensic procedure
13 order in relation to the suspect; or
- 14 (b) at any time after a magistrate has made a forensic procedure
15 order in relation to the suspect.

16 **40B Arrest, removal and detention of suspect**

- 17 (1) This section applies if a police officer has power to arrest a suspect
18 under an arrest and removal order.
- 19 (2) The police officer must—
- 20 (a) use the minimum amount of force necessary to arrest or
21 remove the suspect; and
- 22 (b) before removing the suspect, explain to the suspect the reason
23 for the arrest.
- 24 *Note* The *Crimes Act 1900*, s 252I requires that a responsible person for a
25 child be told if the child is arrested.
- 26 (3) The suspect may be detained in custody for as long as reasonably
27 necessary to carry out the forensic procedure.

- 1 **40C Arrest and removal order—warrant to enter premises**
- 2 (1) This section applies if a magistrate makes an arrest and removal
3 order in relation to a suspect.
- 4 (2) An authorised applicant may apply to a magistrate for a warrant to
5 enter premises to arrest the suspect.
- 6 (3) The application must be sworn and state the grounds on which the
7 warrant is sought.
- 8 *Note* Swear an oath includes make an affirmation (see Legislation Act, dict,
9 pt 1, def *swear*).
- 10 (4) The magistrate may refuse to consider the application until the
11 authorised applicant gives the magistrate all the information the
12 magistrate requires about the application in the way the magistrate
13 requires.
- 14 (5) The magistrate may issue a warrant only if satisfied that the warrant
15 is necessary to enable the arrest of the suspect.
- 16 (6) The warrant must state—
- 17 (a) that a police officer may, with any necessary assistance and
18 force, enter the premises to arrest the suspect; and
- 19 (b) the hours when the premises may be entered; and
- 20 (c) the date (within 7 days after the day the warrant is issued) that
21 the warrant ends.
- 22 (7) An authorised applicant may apply for a warrant in relation to a
23 suspect—
- 24 (a) when the authorised applicant applies for an arrest and removal
25 order in relation to the suspect; or
- 26 (b) at any time after a magistrate has made an arrest and removal
27 order in relation to the suspect.

- 1 **40D Warrant to enter premises—announcement before entry**
2 **and copy of warrant**
- 3 (1) A police officer must, before anyone enters premises under a
4 warrant mentioned in section 40C—
- 5 (a) announce that the officer is authorised to enter the premises;
6 and
- 7 (b) give anyone at the premises an opportunity to allow entry to
8 the premises; and
- 9 (c) if the occupier of the premises, or someone else who
10 apparently represents the occupier, is present at the premises—
11 identify himself or herself to the person.
- 12 (2) A police officer is not required to comply with subsection (1) if the
13 officer believes on reasonable grounds that immediate entry to the
14 premises is required to ensure—
- 15 (a) the safety of the officer or anyone assisting the officer; or
- 16 (b) the safety of anyone at the premises; or
- 17 (c) that the effective execution of the warrant is not frustrated.
- 18 (3) If an occupier of premises, or someone else who apparently
19 represents the occupier, is present at the premises while a warrant is
20 being executed, the police officer or anyone assisting must make
21 available to the person a copy of the warrant.
- 22 (4) In this section:
- 23 ***occupier***, of premises, includes—
- 24 (a) a person believed on reasonable grounds to be an occupier of
25 the premises; and
- 26 (b) a person apparently in charge of the premises.

6 (1) The appointment of Robyn Davies as a member of the Liquor
7 Licensing Board purportedly made by the Minister under
8 section 12 (1) (c) (Membership of board) on 17 October 2008 is
9 taken to be, and always to have been, valid as if the instrument of
10 appointment had been properly—

11 (a) made (including having regard to the Legislation Act,
12 section 228 (Consultation with appropriate Assembly
13 committee)); and

14 (b) notified under the Legislation Act, section 61; and

15 (c) presented to the Legislative Assembly under the Legislation
16 Act, section 64 (1).
