## **Appropriation (Office of the Legislative Assembly) Bill 2017-2018**

### **A Bill for**

An Act to appropriate money for expenditure in relation to the Office of the Legislative Assembly and officers of the Assembly for the financial year beginning on 1 July 2017, and for other purposes

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1   **1           Name of Act**

2           This Act is the *Appropriation (Office of the Legislative Assembly)*  
3           *Act 2017-2018*.

4   **2           Commencement**

5           This Act commences, or is taken to have commenced, on  
6           1 July 2017.

7           *Note*     The naming and commencement provisions automatically commence on  
8                    the notification day (see [Legislation Act](#), s 75 (1)).

9   **3           Purposes of Act**

10          This Act is made for the purposes of—

11          (a) the [Self-Government Act](#), section 57 and section 58; and

12          (b) the *Financial Management Act 1996*, section 6 and section 8.

13   **4           Meaning of *financial year***

14          In this Act:

15          *financial year* means the year beginning on 1 July 2017.

16   **5           Terms used in Financial Management Act 1996**

17          A term used in the *Financial Management Act 1996* has the same  
18          meaning in this Act.

1     **6           Appropriation of \$2 894 000 for auditor-general**

2           The amount mentioned in table 6, column 1 is appropriated to the  
3           auditor-general for net controlled recurrent payments by the  
4           auditor-general in the financial year.
